## Re-organizational Meeting 2021

As advertised in the legal notices of the Standard Speaker, the Packer Township Supervisors re-organized on January 4, 2021 at 6:00 p.m. in the municipal building.

Cory Gerhard called the meeting to order. All were present.

Terry Davis opened the nominations.

Terry Davis made a motion to nominate Cory Gerhard as Chairman and Robert Selert seconded the motion. Vote 2-0

Cory Gerhard made a motion to nominate Terry Davis as Vice-Chairman and Robert Selert seconded the motion. Terry Davis agreed. Vote 3-0

Terry Davis made a motion to nominate Robert Selert as Roadmaster and Cory Gerhard seconded the motion. Vote 2-0

Robert Selert made a motion to close all nominations. Cory Gerhard seconded the motion and Terry Davis agreed. Vote 3-0

Wages were discussed. Robert Selert made a motion to set the wages with no changes. Terry Davis seconded the motion and Cory Gerhard agreed. Vote 3-0

A motion to adopt a Resolution of the Township of Packer in the County of Carbon, Commonwealth of Pennsylvania, Fixing the Tax Rate for 2021 was made by Robert Selert. General purposes .5 mill; Special Fund .1 mill; Fire Protection .7 mill; Per Capita \$5; Estate Transfer Tax .5%; EIT .5%. Terry Davis seconded the motion and Cory Gerhard agreed. Vote 3-0

Robert Selert made a motion to retain Robert Yurchak as Solicitor for the township and planning commission, to retain Gregory Mousseau as Solicitor for the Zoning Hearing Board, to retain Barry Isett & Associates as Zoning Officer and Building Code Official, to retain Sewage Enforcement Officer- Bill Brior and Robert Fugate as the alternate sewage enforcement officer, to appoint Carbon Engineering, Inc. as engineer Township Engineer. Cory Gerhard seconded the motion and Terry Davis agreed. Vote 3-0

Cory Gerhard made a motion to set the mileage rate at the IRS Standard Mileage Rate of \$.575 for 2020 and \$.56 for 2021. Terry Davis seconded the motion and Robert Selert agreed. Vote 3-0

Cory Gerhard made a motion to appoint Robert Selert as Planning Commission Member for another term. Terry Davis seconded the motion. Vote 2-0

Terry Davis made a motion to appoint Neil Craig as Zoning Hearing Board Member for a 3 year term and to appoint Gerard Grega as the Alternate Zoning Hearing Board Member. Robert Selert seconded the motion and Cory Gerhard agreed. Vote 3-0

Cory Gerhard made a motion to set the meeting schedule for 2021. Robert Selert seconded the motion and Terry Davis agreed. Vote 3-0

Robert Selert made a motion to adjourn the re-organizational meeting and Terry Davis seconded the motion. Cory Gerhard agreed. Vote 3-0

The meeting was adjourned at 6:09 p.m.
